- ii) Last date & time for submission of bids shall be : 19.11.2022 upto 12:00 PM
- iii) Date & time of opening of Technical Bid : 19.11.2022 at 12:30 PM

3. The Bidding Documents can be purchased from the Collage Office. The document purchased from the Collage Office should not be tempered, and if any such tempering is detected before or after the opening of bids, the bidder shall be debarred for a period of 6 months.
4. The bidders should keep checking the Collage website <http://mbspau.ac.in> for any corrigendum to the notice/bidding documents till the date of submission of bids, and the bidder should incorporate the same in his bid documents.
5. The cost of the bidding documents (non-refundable) shall be paid by bank draft or online transfer through Bank Cheque/DD in favour of Principal Prof. Gursewak Singh Physical Collage of Education, Patiala.
6. Bid Security/Earnest Money Deposit (EMD) of the amount shall be paid through Bank FDR/DD/Cheques etc in favour of Principal Prof. Gursewak Singh Physical Collage of Education, Patiala.

receipt of such letter, which will be sent through registered post/E-mail/courier.

12. Technical Bids will be opened on the day & time as specified in the above table, in the presence of the bidders who wish to attend. If the office happens to be closed on the date of receipt of the bids as specified, the bids will be received and opened on the next working day at the same time and venue.
13. Bid(s) once submitted cannot be resubmitted or withdrawn.
14. Conditional bids and the bids not meeting the qualifying criteria on the date of receipt of bids shall be summarily rejected.
15. The undersigned has the right to accept or reject any or all bids without assigning any reason.
